- 🚫 If the check shows your article is mostly written by AI – roughly 50% (or more) AI-generated – it will be treated as not genuinely student-written.
- 🚫 In such cases, the article will be disqualified from the contest/publishing.

### What's still okay

- ✓ Using AI for ideas, outlines, topic research, grammar suggestions, or improving wording, as long as the final writing is clearly yours.
- ✓ Your voice, structure, arguments, and examples should be human-led, not "AI copy-paste"

## 2. Author Details (Mandatory)

Every article must clearly mention:

- Full Name
- College Name
- Current Year & Sem
- College ID Proof
- Social Media ID/LinkedIn ID

## 4. Topic & Deadline Compliance

- Articles must be written only on the announced topic and submitted within the stated deadline.
- 🚫 Late submissions or off-topic articles will not be considered.
